



MUSIC FOR SCHOOLS

Thanks to the generosity of many donors, the Wells Fargo Center for the Arts Music For Schools program is able to offer the instrument lending library. The purpose is to make instruments available to students who might otherwise not have the opportunity to play. Music For Schools uses the following criteria:

1. A request must be completed for each student applying for an instrument. Please submit applications for students who will be responsible for the care of an instrument; please do not request instruments for students who are typically irresponsible. Once placed, the parent(s) and school assume financial responsibility in the event of loss or damage. Incomplete applications will not be considered.
2. Priority is given to students with demonstrated financial need. However, because our goal is to have all the instruments used in school music programs, those requests not based on financial need will be placed on a first come, first served basis after initial placements are made.
3. Though most requests occur at the beginning of the school year, applications are accepted throughout the year and are filled according to availability.
4. Instruments are checked out via the music teacher or principal and are on loan for the entire school year. Upon return, we ask that maintenance information be provided. Repairs for non-routine maintenance are the responsibility of the parent(s) or school, as needed.
5. Teachers are key to ensuring proper use and handling of the instruments. Music teachers henceforth agree to the following:
 - Teaching proper storage, use, cleaning, and maintenance of instrument(s).
 - Ensuring the student is attending classes and the instrument is being played.
 - If a student drops, returning the instrument immediately.
 - Notifying Music For Schools immediately in the event of loss or damage.
 - At the end of the year, returning the instrument by the due date and notifying Music For Schools of any and all maintenance needs.

Our mission is to “encourage, support, and expand music education opportunities for youth.” We are pleased to offer students the use of these instruments knowing they make a positive difference in your school music program.
